

PETITION FOR REDETERMINATION OF BENEFITS OF DRAINAGE SYSTEM

TO: THE STEARNS COUNTY BOARD OF COMMISSIONS ACTING AS THE DRAINAGE AUTHORITY FOR STEARNS COUNTY DITCH NO. 28.

Petitioners respectfully represent, state and request the following:

1. The undersigned Petitioners constitute: (a) at least 26% of the owners of property that is benefited or damaged by Stearns County Ditch No. 28 ("CD 28") or (2) the owners of at least 26% of the property that is benefited or damaged by CD 28.

2. The benefits and damages of record previously determined for CD 28 do not reflect reasonable present-day land value, and the benefitted and damaged areas of CD 28 have changed since benefits and damages were previously determined.

WHEREFORE, the Petitioners respectfully request the following:

- a. That the drainage authority accept this Petition, review it and determine that it is legally adequate; and
- b. That, pursuant to Minn. Stat. § 103E.351 subd. 1, the drainage authority determine that the benefits or damages of record for CD 28 do not reflect reasonable present-day land value, and the benefitted and damaged areas of CD 28 have changed since benefits and damages were previously determined.
- c. That, pursuant to Minn. Stat. § 103E.351 subd. 1, the drainage authority appoint three viewers to determined and report the benefits and damages and the benefitted and damaged areas.
